## Residential

Single / Multi / Family Dwelling – frame vinyl	\$ 80.00 per sq. ft.
Attached garage new construction	\$ 40.00 per sq. ft.
SFR – Frame w/brick, stone or dryvit – front only	Add \$10,000 to valuation
SFR – All brick, stone or dryvit	Add \$40,000 to valuation
Detached structures – Garages – Pole Barns	\$ 25.00 per sq. ft.
Storage Sheds	\$ 20.00 per sq. ft.
Porches and decks without a roof	\$ 25.00 per sq. ft.
Porches and decks with a roof	\$ 35.00 per sq. ft.

(Section 325.04 Failure to Secure Zoning Permit will automatically double the permit fee.)*

Professional / Business / Office / Retail / Restaurant Remodel	\$ Contractor Valuation
Industrial / Manufacturing / Assembly	\$ 60.00 per sq. ft.

## New Construction Procedures for Zoning Permit / Section 325.01

- Accurate Site Plan
- Complete Set of Prints – 24 hours in advance for review of Site Plan and Prints
- Clearly marked property pins
- Call the Zoning Department before and after digging foundation
- Modifications to building found on final inspection that have not been reported will be subject to Section 325.04
